1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £ 14,061 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

Auditor General's report

Audit opinion – Unqualified

On the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters arising and recommendations

Expenditure under section 137 Local Government Act 1972

The Council discloses in its notes to the accounts that it spent £14,061 using the power set out in section 137 (s137) of the 1972 Act. S137 allows the Council to spend up to £8.41 per elector which in the Council's opinion is in the interest of the area or its inhabitants. However, the powers granted by other existing statutes must be used in the first instance. Much of the expenditure disclosed in the note is covered by other statutory provisions which take precedence over section 137.

We recommend that the Council reviews its classification of expenditure and only discloses under s137 that which s137 properly applies to.
