- **51 To approve and confirm the minutes of the meeting held on 13th July 23.** The minutes of the meeting were approved as an accurate reflection of the meeting.

53 Matters Arising from the meeting of Council on 13th July 23.

Item 007.01 – The Chair (CIIr D Nicholas) received a letter from Aneurin Bevan University Health Board (ABUHB) regarding the potential closing of Meddygfa Cwm Rhymni surgery at Riverside Walk in Deri. CIIr Nicholas was deeply concerned about this. The local community has praised the great care they receive from the surgery and a number of patients are elderly and would struggle to access the care they need if they have to find

transport. The transport links in the area are unreliable and this is likely to put some residents off travelling to get the care they need, likely having a catastrophic effect on any underlying illness if not diagnosed.

There are also concerns about the consultation questionnaire, as it's been designed in a way that is loaded with questions that will not evidence the cause and effect of the closure.

RESOLVED TO RECOMMEND: The Clerk will write to ABUHB raising concerns about the potential closure, and Emily Janes will write an article in the Caerphilly Observer.

Update from the June 2023 meeting – The clerk has received no update regarding the closure yet.

Update from the July 2023 meeting – The clerk was informed that the closure panel was held on 7th June 2023, and the outcome would be presented to the board on 19th July 2023. The full decision will be discussed at the September 2023 meeting.

Update from the September 2023 meeting – Council received a letter from the Interim Divisional Director of Primary Care and Networks. Following a panel held on 7th June 2023, the recommendation was to support the application to close Deri Branch Surgery. The surgery will officially close from Friday 20th October 2023. Patients who currently access services at Deri will be able to continue to access the General Medical Services from the main site in Rhymney, Tredegar after this time.

Item 024 - Community Council Budget and Financial Reconciliation 2023-24

Update from the June 2023 – deferred budget entry (Section 137 OAP trip).

RESOLVED TO RECOMMEND: Both villages (Deri and Fochriw) were authorised a budget of £700 per bus. The clerk was authorised to pay as long as £700 or under.

Update from the July 2023 meeting – Councillor D Nicholas thanked Councillor J Gibbings for organising the Deri trip.

Update from the September 2023 meeting – Updates on the Deri and Fochriw trips to Weston Super Mare and Herefordshire were provided by Councillors J Gibbings and D Johnson. The trips were well attended even though some didn't turn up on the day. There was a surplus un-spent amount totaling £50, which Cllr J Gibbings gave to the Clerk to pay into the council bank account.

There was also a general discussion regarding the planning, time of year etc. for the trip next year.

RESOLVED TO RECOMMEND: The Clerk offered to design a questionnaire to distribute to gather ideas on the best time to hold the 2024 trip i.e. Summer or Christmas etc. The Clerk will bring copies to the October 2023 meeting.

Anti-social Behaviour (ASB) & Off-road vehicles- (Twyn Carno, Moriah, Pontlottyn, Darren Valley & New Tredegar)

Throughout August there was a significant increase in calls relating to ASB, particularly in Rhymney High Street, War Memorial Park and surrounding areas.

In order to tackle and prevent existing and any further incidents an ASB Operation was put in place for this area. The main focus of this operation was to

keep streets and the community safe by implementing numerous dispersal orders during times where levels of ASB were at the highest. The dispersal orders gave us the power to issue Direction to Leave Forms (section 35 of Antisocial Behaviour Crime and Policing Act 2014) to any groups or persons congregating or acting in an anti-social manner on the High Street and surrounding area.

During the operation Gwent Police deployed additional resources to the area, including, Community Support Officers, Neighbourhood and Response Police Officers, as well as Roads Policing Specialist Operations when required.

The outcome of the operation was positive and resulted in identifying further offenders. ASB referrals were submitted, a number of offenders were arrested and interviewed.

A number of the youths involved remain under investigation for the offences disclosed with 3 to date referred to the Youth Offending Services.

There was a discussion about the law and e-bikes as it's becoming a huge problem not only in Darran Valley, but throughout South Wales. **RESOLVED TO RECOMMEND:** The PCO's will find out about the law in regards to e-bikes and report back at the next meeting.

It was also noted that fences are being cut in Parc Cwm Darran and sheep are escaping into the park and villages. The offenders seem to be aware of the shift patterns of the park rangers and other staff. Extra patrols were recommended.

56 To receive Community Council Correspondence

The Clerk received a letter from the Caerphilly CBC community cleansing team. The team will be working in the area week commencing 18th September 2023.

They wanted to know if the community council could identify any areas that require additional cleaning. If there are any particular areas Cllr. R Chapman will inform the team directly.

Update from the July 2023 meeting – The Clerk was asked to write a formal complaint to the head of Caerphilly CBC, as the meeting room at Parc Cwm Darran is still not available for evening meetings.

Update from the September 2023 meeting – Cllr R Chapman has arranged a meeting with the key stakeholders to try and resolve the issues with resuming meetings at Parc Cwm Darran. In the meantime, meetings will be rotated between Fochriw and Deri community centres', depending on availability.
