66.01 - The Clerk received an e-mail from Aneurin Bevan UHB regarding the provision of minor injury unit services. The Clerk will post the information on the Darran Valley CC website.

- 66.02– Cllr J Gibbings forwarded an article to the Clerk regarding participatory budgeting. The Clerk will find out more information and bring to the November 2023 meeting.
- 66.03– Bus stop enhancement Aelybryn Street, Fochriw the Clerk received an e-mail from the Passenger Transport Officer at Caerphilly CBC. As part of the mid valley bus stop enhancement scheme, the works to improve the bus stop is scheduled to be commenced week commencing 9<sup>th</sup> October 2023.
- 66.04 An e-mail from the Senior Engineer at Caerphilly CBC 'In accordance with the 'Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996' I am undertaking a consultation process in accordance with the Regulations and seeking your views with regard to the introduction of a 24-hour rural 'Clearway' traffic order on Fochriw Road near the Trecatti landfill site. The reason for this proposal is that lorries are parking on the public highway when waiting for the Trecatti landfill site to open which cause other vehicles to overtake on the opposite side of the road where there is a risk of collision with oncoming vehicles. The provision of this type of order will prevent this type of parking along the road and remove the need for vehicles to overtake which in turn will reduce the risk of collision with oncoming vehicles. The proposed order will improve road safety at this location. I would be grateful for any comments you may have regarding the proposal by 20th October 2023.'
